Borough of Park Ridge Request for Qualifications From Certified Public Accountants

Interested in Serving as "Borough Auditor" to the Borough of Park Ridge For the Period January 1, 2024 through December 31, 2024 Dated: November 1, 2023

Introduction

The Borough of Park Ridge ("Borough") is soliciting Qualification Statements from interested persons and/or firms for the provision of Professional Accounting and Auditing Services as more particularly described herein. Through a Request for Qualification process described herein, persons and/or firms interested in assisting the Borough with the provision of such services must prepare and submit a Qualification Statement in accordance with the procedure and schedule in this RFQ. The Borough will review Qualification Statements only from those firms that submit a Qualification Statement which includes all the information required to be included as described herein (in the sole judgment of the Borough). The Borough intends to qualify person(s) and/or firm(s) that (a) possesses the professional, financial and administrative capabilities to provide the proposed services, and (b) will agree to work under the compensation terms and conditions determined by the Borough to provide the greatest benefit to the taxpayers of Park Ridge. The successful Respondent will be awarded a one (1) year professional services contract.

The successful Respondent must have significant experience in providing public accounting and auditing services to New Jersey municipalities and/or other New Jersey public entities. Preference shall be given to firms that employ at least one licensed accountant who is certified by the Government Finance Officers Association (GFOA). The successful Respondent will provide the Borough with professional accounting services relating, but not necessarily limited to:

1) Auditing the balance sheets of the individual funds of the Borough as of and for the year ended December 31, 2023, and the related statements of operations and changes in fund balances for the year then ended. The audit shall be conducted in accordance with auditing standards generally accepted in the United States of America, the audit requirements prescribed by the Division of Local Government Services, Department of Community Affairs, State of New Jersey and the standards applicable to financial audits contained in Government Auditing Standards issued by the Comptroller General of the United States and other procedures we consider necessary to enable the Borough to express an unqualified opinion that the financial statements are fairly presented, in all material respects, in conformity with generally accepted accounting principles. The audits will include the supplementary information,

Schedules of Federal and State of New Jersey Awards, as required by U.S. Office of Management and Budget Circular A-133, Audits of States, Local Governments, and Non-Profit Organization and 8State of New Jersey OMB Circular 04-04, Single Audit Policy for Recipients of Federal Grants, State Grants and State Aid, (if applicable) and is not a required part of the basic financial statements. In accordance with Government Auditing Standards, Respondent will issue a report on the consideration of the internal control over financial reporting and the tests of its compliance with certain provisions of laws, regulations, contracts, and grants. Respondent will issue a report based on consideration of the internal control over compliance in accordance with OMB Circular A-133 and State of New Jersey OMB Circular 04-04 and our test of its compliance with requirements applicable to each major program (if applicable).

- 2) Prepare the Annual Financial Statement for the year ending December 31, 2019 in accordance with the requirements of the State of New Jersey Division of Local Government Services. This report will be prepared on management's chart of accounts and trial balance and any adjusting, correcting, and closing entries that have been approved by management.
- 3) To prepare the annual debt statement for the year ending December 31, 2019 in accordance with the requirements of the State of New Jersey Division of Local Government Services. This statement will be prepared based on management's chart of accounts and trial balance and any adjusting, correcting, and closing entries that have been approved by management.
- 4) To assist management in the compiling of the information for the Annual Budget for the year 2019 in accordance with the requirements of the State of New Jersey Division of Local Government Services. All information necessary to prepare the budget will be provided from the Borough's management.
- 5) Any matters necessary and proper for Borough auditors to handle; and any other matter as directed by the Borough.

Definitions

The following definitions shall apply to and are used in this Request for Qualifications:

"Borough" - refers to the Borough of Park Ridge.

"<u>Qualification Statement</u>" - refers to the complete responses to this RFQ submitted by the Respondents.

"Qualified Respondent" - refers to those Respondents who (in the sole judgment of the Borough) have satisfied the qualification criteria set forth in this RFQ.

"<u>RFQ</u>" - refers to this Request for Qualifications, including any amendments thereof or supplements thereto.

"<u>Respondent</u>" or "<u>Respondents</u>" - refers to the interested firm(s) that submit a Qualification Statement.

Procurement Process and Schedule.

The selection of Qualified Respondents is not subject to the provisions of the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seg. The selection is subject to the "New Jersey Local Unit Pay-to-Play" Law, N.J.S.A. 19:44A-20.4 et seg., however, the Borough has structured a procurement process that seeks to obtain the desired results described above, while establishing a competitive process to assure that each person and/or firm is provided an equal opportunity to submit a Qualification Statement in response to the RFQ Qualification Statements will be evaluated in accordance with the criteria set forth in this RFQ. which will be applied in the same manner to each Qualification Statement received. Qualification Statements will be reviewed and evaluated by the Borough and its legal and/or financial advisors (collectively, the "Review Team"). The Qualification Statements will be reviewed to determine if the Respondent has met the minimum professional, administrative and financial areas described in this RFQ. Under no circumstances will a member of the review team review responses to an RFQ for a job which they or their firm submitted a response. Based upon the totality of the information contained in the Qualification Statement, including information about the reputation and experience of each Respondent, the Borough will (in its sole judgment) determine which Respondents are qualified (from professional, administrative and financial standpoints).

Each Respondent that meets the requirements of the RFQ (in the sole judgment of the Borough) will be designated as a Qualified Respondent and will be given the opportunity to participate in the selection process determined by the Borough. The RFQ process commences with the issuance of this RFQ. The steps involved in the process and the anticipated completion dates are set forth in Table 1, Procurement Schedule. The Borough reserves the right to, among other

things, amend, modify or alter the Procurement Schedule upon notice to all potential Respondents.

All communications concerning this RFQ or the RFQ process shall be directed to the Borough's Designated Contact Person, in writing.

Subsequent to issuance of this RFQ, the Borough (through the issuance of addenda to all firms that have received a copy of the RFQ) may modify, supplement or amend the provisions of this RFQ in order to respond to inquiries received from prospective Respondents or as otherwise deemed necessary or appropriate by (and in the sole judgment of) the Borough.

- 5. At least four (4) municipal government references, three (3) of which must have knowledge of your service to public entities;
- 6. Examples of your record of success (or significant achievements) servicing public entities;
- 7. The Respondent's ability to provide the services in a timely fashion (including staffing, familiarity and location of key staff);
- 8. Cost details, including the hourly rates of each of the individuals who will perform the services and the time estimates for each individual, all expenses, and where appropriate, total cost of "not to exceed" amount;
- 9. Evidence of compliance with New Jersey affirmative action requirements (e.g. Certificate of Employee Information Report);
- 10. A copy of your New Jersey Business Registration Certificate;
- 11. A copy of any of any required professional federal and/or state licenses to perform the required activities;
- 12. A narrative statement of the Respondent's understanding of the Borough's needs and goals;
- 13. List all immediate relatives of Principal(s) of the Respondent who are Borough employees or elected officials of the Borough. For purposes of the above, "immediate relative" means a spouse, parent, stepparent, brother, sister, child, stepchild, direct-line aunt or uncle, grandparent, grandchild, and in-laws by reason of relation;

- 14. List any judgments within the last three years in which the Respondent, or its members and/or employees, have been adjudicated liable for professional malpractice. If yes, please explain;
- 15. Whether the business organization is now or has been involved in any bankruptcy or re-organization proceedings in the last ten (10) years. If yes, please explain; and
- 16. A copy of a current certificate of insurance evidencing professional liability insurance, with limits of not less than One Million Dollars (\$1,000,000.00) each claim/\$1,000,000 annual aggregate. The Borough reserves the right to request additional financial information from the Respondent in the event that said insurance policy contains either a deductible in excess of \$20,000.00 or any self- insured retention limits.
- 17. Any other information that the interested Respondent deems relevant.

Selection Criteria

The selection criteria used in awarding a contract or agreement for professional services as described herein shall include:

- 1. Qualifications of the individuals who will perform the tasks and the amounts of their respective participation;
- 2. Experience and references;
- 3. Ability to perform the task in a timely fashion, including staffing and familiarity with the subject matter;
- 4. Cost competitiveness;
- 5. Describe those portions of the Respondent's services, if any, that are sub-contracted out. Identify all subcontractors the Respondent anticipates using in connection with this project.
- 6. State whether Respondent normally employ union or non-union employees.
