### 2016 Animal License Renewal Form *All 2015 Licenses Expire on December 31<sup>st</sup>*

Licenses for animals registered in the Borough of Park Ridge will expire on December 31, 2015. Owners will have until 2/29/16 to renew their animals' licenses. Failure to do so violates a borough ordinance requiring the licensing of all animals within the Borough. A penalty of \$10.00 per animal shall be charged for any license that is not renewed on or before 2/29/16.

1. Make checks payable to 'Borough of Park Ridge' in the amount indicated in the 'Total' on the reverse side of this sheet.
2. Enclose a self-addressed stamped envelope with \$.71 postage to have your license returned by mail.
3. Include proof of updated rabies vaccination. State law mandates that the rabies vaccination **must be good THROUGH 10/31/16**. Please note your animal's rabies information on the reverse side of this sheet as it appears in our computer system. *If your animal is in need of a rabies vaccination, the Borough is holding a FREE RABIES CLINIC on Nov. 4, 2015.*
4. If you are applying for a new license or if your dog has been spayed/neutered during the last year, please provide proof of this as well.

### **2016 ANIMAL LICENSE APPLICATION**

Licenses for animals registered in the Borough of Park Ridge will expire on December 31, 2015. Owners will have until **February 29, 2016** to renew their animals' licenses. Failure to do so violates a borough ordinance requiring the licensing of all animals within the Borough.

**A penalty of \$10 shall be charged for every animal license that is not renewed on or before 2/29/16.**

2. Enclose a self-addressed stamped envelope with \$.71 postage to have your license returned by mail.
  
3. **Include proof of updated rabies vaccination.** State law mandates that the rabies vaccination must be valid through **10/31/16.** Please note your animal's rabies information on the reverse side of this sheet as it appears in our computer system
