Mayor Maguire Reads Compliance Statement, as required by Open Public Meeting Act, P.L. 1975, Chapter 231.

Mayor Maguire: Before I suspend the regular order of business, I do want to express our thoughts and prayers for the attacks in Florida and for the families of the victims there. Also, close to home here, a resident of Park Ridge, an active member of our community, Eric von der Lieth is in the hospital and very ill at this point so our thoughts and prayers go out to him and his family as well.

SUSPEND THE REGULAR ORDER OF BUSINESS

Mayor Maguire calls for a motion to suspend the regular order of business to **Administer the Oaths of Office for the Park Ridge Police Reserves and to Present the Certificate of Induction of Mayor Donald Ruschman to the Elected Officials Hall of Fame.**

A motion was made by Council President Bosi and seconded by Councilman Misciagna.

Mayor Maguire: Hopefully folks all recognize our Police Chief and our Police Reserves. They are always out at different events helping us out – be it traffic control or you name it – different events we have in town – certainly an integral part of our community. We have two new officers being inducted into what is really a class group of folks. They really are role models. Chief Witte has been with us now for forty-one years and all of this is done in conjunction with our Police Chief, Chief Madden, and I do thank him for all of his efforts because there is a lot of training that goes into having the Police Reserves. It may seem simple enough, but it is a complicated job and there are a lot of rules and regulations and things these folks have to follow. Without further ado, I am going to swear these guys in.

Chief Witte: Thank you very much. I just want to say welcome aboard. Chris, this is his second time. He was in the Reserves a few years ago and due to school he left and now he is back with us so we are looking forward to having you guys join the ranks. I know this weekend was a busy weekend because you were out for the town picnic and the fireworks also. Welcome aboard and we will be looking forward to working with you.

Mayor Maguire is joined by Councilman Oppelt and Mayor Ruschman.

Mayor Maguire: I've asked Councilman Oppelt to come up here today to join me because tonight we are recognizing a good friend of mine and a good friend of the Park Ridge community. Someone who you will recognize the name because he was our Mayor for ten years and prior to that served ten years as a Councilman in Park Ridge.

He doesn't need any introduction. Everybody knows former Mayor, Don Ruschman. I will share a little bit. I had surgery last week but I needed to be here for this because it is a distinct honor to recognize this gentleman because he was a role model to me as I was coming through the Council and his dedication to the Borough of Park Ridge has been one that I try to emulate and certainly is someone that is going to be hard to be imitated. Twenty years of dedication of elected official status to the Borough of Park Ridge is quite an achievement. I know for myself, my seven years of involvement, it has been a lot of work – certainly quite rewarding – but also quite a lot of work and a lot of sacrifices along the way. So Vi, I see you are here tonight as well, and I certainly want to recognize you because I can you tell you without my wife pushing behind me, I wouldn't be standing here tonight and doing all the things I do for Park Ridge. Thank you, Vi, for sharing him with us. Folks that don't know, Don worked for Verizon Communications, which is where I work as well. We certainly shared that when I first met him and we shared a lot of thoughts and ideas and certainly moved a lot of things forward during our time on the Council and working with him.

We are here tonight because my friend, Bob Oppelt, followed up on this recognition. There is a Hall of Fame and there is League of Municipalities - all the towns get together and they have what they call a "Hall of Fame." It is for people who have the distinction of serving twenty plus years of elected status. Don served as a Councilman for ten years and was also the Mayor for ten years and he was our Mayor during a difficult time. I recognized the attacks in Florida that just occurred and how those attacks certainly hit home and I am hoping that they unify us similar to what happened after 9/11 because for folks that were in Park Ridge after 9/11, Don Ruschman was the Mayor and he was the one that brought everyone together. There were candlelight ceremonies that he held and led. It was a difficult time but he was the Mayor and he stepped up and accepted that and I think everyone should recognize him for that and for his leadership during that time. As we see now, the war on terrorism continues and we do need to be unified and we need to take that experience and channel it and then unify against this evil. I do believe, like I hope everyone does, that there is more good in this world than evil and that we will overcome. Don, I think you really made that clear to everyone during that time so I certainly want to recognize you for that.

Some key facts - I think there are only 560 people in the history of the State of the New Jersey that have received this honor. You can imagine, there is about 560 municipalities in the State of New Jersey. Each one of those has a Council and a Mayor, but over the course of history, only 560 people have achieved this milestone of twenty years of elected status. Without further ado, I do have a proclamation that was presented at the League of Municipalities. There was an Induction Ceremony during the 24th Annual Mayors' Legislative Day which was a fitting tribute to your more than twenty years of public service as a local governing body member. Here is a letter from the President of the League of Municipalities as well as an official proclamation and I will read the proclamation.

PROCLAMATION

Donald J. Ruschman, Mayor, Park Ridge Borough, having selflessly served in elected municipal office for a tenure not less than twenty years as a municipal governing body member and having dedicated that time to the cause of good local government is hereby inducted as a Member of the New Jersey State League of Municipalities Elected Officials Hall of Fame on this day, February 2016.

Mayor Maguire: Don, without further ado, I do want to congratulate you and I want to again congratulate Vi for sticking by him all these years.

Mayor Ruschman: Not accustomed as I am to giving speeches, I have a few notes here. I would like to first of all thank the Mayor and the Council for giving me this honor tonight. I do appreciate it, and in particular, to thank Bob Oppelt, who I know you were a big part of it, Bob – and as always, Ms. O’Donnell, who is always a part of anything like this - so thank you both for helping me out on this. I would also like to thank my friends, my family, particularly my wife, Vi, who I’m sure for the twenty years felt like she was ignored and I didn’t pay any attention to her, but she found out these last four years what a pain in the butt I am and she probably wishes I was going back on the Mayor and Council.

This recognition tonight is great and while it is greatly appreciated it is nothing compared to the honor that I have had to be allowed to serve the people and the town of Park Ridge. I really do appreciate that and I want to thank all the people too as part of the town of Park Ridge for having this honor tonight. As anyone who has an opportunity to serve on any civil duty within the town, such as the Mayor and the Council, the School Board, the many Boards that we have and the many committees that we have, and certainly not to forget all the sports programs that we have within town, you know that the satisfaction of doing the job itself is a reward to itself.

Many of you I know have served more than twenty years in the job that you have been doing, so certainly you deserve congratulations and the thanks of the people of Park Ridge – so congratulations to all of you. Now as many of you know, I am not a long speaker and I know you have some work tonight. I want to thank all you people for coming for me tonight. I really am impressed, but I know you have a lot of work to do so I’ll just say once again, thank you to all of you, and now I will get back to bothering Vi. Thank you.

Mayor Maguire: Don, I think all these people are here to see you. I’m hoping anyway, but I certainly learned a lot from you and I do want to again thank you from myself, for the Council, for this community for everything that you’ve done. I could go on again with stories of things that he has taught me and I see Vi sitting there. The key item he told me is when you get up there the first thing you do is recognize your wife. Don’t forget to recognize your wife, Terry. Again, Don, thank you. We are going to take a quick recess and we will be back in a minute. Thank you.

PUBLIC PRIVILEGE OF THE FLOOR:

Mayor Maguire asks if anyone present wishes to be heard on any matter.

Upon recognition by the Mayor, the person shall proceed to the floor and give his/her name and address in an audible tone of voice for the records. Unless further time is granted by the Council, he/she shall limit his/her statement to five (5) minutes. Statements shall be addressed to the Council as a body and not to any member thereof. No person, other than the person having the floor, shall be permitted to enter into any discussion, without recognition by the Mayor.

Burton Hall – 98 N. 5th Street - Good evening. Thanks for all of you who came out this evening. As a Park Ridge resident of some thirty years, I am here because I am deeply concerned for the future of Park Ridge because of the recent efforts to make it a high density transit hub. I do not question the good intentions of present or past elected officials. However, I do believe that their good faith efforts to benefit our town have permitted State planners utilizing the Transit Village agenda like a Trojan horse to jeopardize the future of Park Ridge as we know it. The plan recently approved by this Governing Body would forever change for the worse the character of Park Ridge and thus should be revisited. To quote the recently approved Park Ridge Borough Ordinance, “The plan achieves several goals and objectives of the Master Plan including encouraging high density development.” Park Ridge was never intended as, nor is it suitable to be, a high density transit hub. To pursue such a course would overwhelm its resources and destroy its character. The new ordinance included an increase in allowable height limit from three to five stories. While Park Ridge residents appreciate and favor intelligent growth, you will be hard-pressed to find a person in favor of increasing height limits from the present three stories. Tree lined streets connecting friendly neighborhoods of single family homes define the character of Park Ridge. This is the “Park Ridge brand” and a brand is a promise. It is that promise that earns the trust of newcomers who choose to call Park Ridge home. It contributes to the value of our homes. It is important to note the state goal for a Transit Village. The New Jersey Department of Transportation states the goal as “to encourage dense, mixed use development within a half mile of train stations.” That pretty much reaches past Pascack Road on the west and East Brook School on the east. This is wrong. It is so wrong for Park Ridge.

Look at the other towns that have become Transit Villages. They include South Amboy, Rahway, Bloomfield, Matawan, Rutherford, New Brunswick, Journal Square, Jersey City, Elizabeth, Orange, East Orange, Linden, Irvington, and Plainfield. They all have decidedly different issues and needs than Park Ridge. Not one other town in the Pascack Valley wants to be a Transit Village and none are. Only one other town in all of Bergen County wanted to be a Transit Village – that is Rutherford - and it was looking for a way to deal with remediation of a toxic waste site. For small healthy towns like Park Ridge taking Transit Village money from the State is making a deal with the devil and now we can see that there is hell to pay.

As it now stands, the recent ordinance change will allow for a five story mixed use structure. We know that with one, many such structures will pop up like mushrooms. To the best of my knowledge, and those I’ve spoken with, presently there are no five story residential buildings in the Pascack Valley and no other town in the Pascack Valley will permit one. Increasing our allowable height limit is like drawing a target on our town for high density residential development. The statement has been made that Park Ridge must provide high density developers with incentives, such as expanded heights, or they will not come to build the Transit Village dictated high-rises. Maybe it is only me, but I’ve noticed single family homes being built with the only apparent incentive being that they are in a Park Ridge neighborhood. So we are being subjected to a State Plan that will degrade our community and will not work unless we, the community, pride the incentives to lure those who will do the damage. That is crazy. Most assuredly, the future will see more battles to preserve the character of Park Ridge in the face of outrageous and outsized projects. Park Ridge must be ready and unified. This is not us or them. I respect the job you do greatly and to some degree appreciate the pressures. That being said, what we do tonight is going to impact this town long after we are dust. We have people who believe in this town. Brian – how long have you been years – what did you just do with your house?

Mayor Maguire: Mr. Hall, if you could, just address the Council please.

Mr. Hall: Sure. Therefore, we call upon the Park Ridge Town Council to do the following: (1) Reinstate the three story maximum height limit (2) Commit to maintaining the present corporate park zoning (3) Withdraw from participation in the Transit Village initiative because it is poison.

If that is impossible, and Mr. Ten Hoeve may said, “I would love to do it, but...” then what we would ask is apply its Transit Village principles as sparingly as possible, and lastly, be prepared in advance for the coming battles. Look at surrounding towns and arm this town with the ordinances it needs to preserve its character, promote intelligent growth, and keep true to the promise that is Park Ridge. And I would like to ask one thing because I know votes can’t be taken - I would really like to ask before this crowd to poll the Town Council to see how each member feels about reinstating the three story limit. May we ask that as a group?

Mayor Maguire: I don’t think that is appropriate. It is not appropriate.

Mr. Hall: Why not?

Mayor Maguire: Because we just voted at the last meeting which I will go through and I will try to clarify some of the comments that Mr. Hall made, but at the last meeting there was a Redevelopment Plan that was adopted that the Council voted unanimously to approve and there have been several presentations on this. With that said, if you are done I will try to address your comments. I don’t know if you had any questions.

Mr. Ten Hoeve: Just so you understand, this isn’t a dialogue. You have an opportunity to make a presentation and if you are finished, then the Council can respond or not respond. It is not going to engage in a discussion with you here.

Mayor Maguire: Let me try to respond.

Mr. Hall: It might be good to just having engage a discussion with the community because apparently their opinion hasn’t been sought out and at this point has now been completed.

Mayor Maguire: Let me clarify.

Mr. Hall: I thank you for your time.

Mayor Maguire: Thank you, Mr. Hall. I certainly appreciate it and we always appreciate input from residents. If there is anyone out there thinking that we don’t appreciate the input or don’t want the input they are mistaken. We do welcome the input and I thank you, Mr. Hall. Mr. Hall and I have had this discussion before and certainly disagree in terms of what Transit Village mean as well as what a redevelopment zone is. They are two very different things and I believe that there is a lot of confusion about that, and whether we are subject to a State Plan. Folks, just so know, Park Ridge is not subject to any State Plan or State Mandate, nor does the Transit Village designation require us to do anything or force us to develop anything. What we’ve done, right, it is a good question – why did we do the Transit Village designation?

The Transit Village designation is something that the Department of Transportation came up with and they said, “for folks that have train stations – if you develop around the train station – mixed use, residential and business, you would be eligible for what is called “A Transit Village designation.” And what that does is it enables you to apply for grants as well as other incentives from the State. It moves you to the top of the line for grants. There is no requirement for development associated with that. It is completely up to Park Ridge. The Park Ridge Planning Board and Zoning Board – in New Jersey we have something that is called “local home rule.” Park Ridge is solely able to control what is developed in the town. The State has no say in what is developed here in Park Ridge so let’s get that out of the way. So we went ahead and we approached the DOT. We said, “O.k. what is required of a Transit Village status?” We went through the list, and Park Ridge with everything we’ve done, qualifies today for Transit Village status. If we develop nothing else in Park Ridge, we would qualify – we qualified – we have it – Transit Village status. So Transit Village has nothing to do with what was just approved as a redevelopment zone. The redevelopment zone was approved for the waste transfer station site

and this is going back many, many years. It has been talked about as to how do we get the waste transfer site out of the center of town and get some type of ratable in there and get some development going. The best way to do that was something called “creating a redevelopment zone” and if you look at every town in the Pascack Valley, they are all looking at a redevelopment zone. They all have an area around the train stations that has not been developed for many, many years and they want to try to encourage development around the train station.

So here we have a waste transfer station in the center of town with a bunch of disjointed properties around it. So now we need a developer – you need somebody that is going to come in and say, “I’m going to assemble all these properties and put something that is cohesive and looks nice in that area.” So, yes, that brings density with it and this Council and the Planning Board all looked at that, and if you look at us up here, we are residents – there is no one up here that is doing anything other than what is in the best interest of Park Ridge. If we thought for a minute that any development in the downtown on that waste transfer site that was going to impact the character of Park Ridge, we would not do it! Let’s be clear. We all live and breathe Park Ridge. You heard Don Ruschman, friend of mine – worked for this town twenty years – all of us up here, all of us live and breathe and bleed for Park Ridge and the quality that we have here in Park Ridge and because we all believe that Park Ridge is unique and we have character, and that a residential building on the waste transfer site is not going to change the character of Park Ridge. So folks, you hear it from me, because I believe in what we are doing and I believe that putting a building and hopefully getting a developer because to clarify the process required us to create a redevelopment zone. The next step is to get a developer and then that developer we would negotiate to come up with the plan that would then be presented to the Planning Board. So, yes, did we look it and say, “He may need five stories in order to get that assemblage of properties and make it economically viable to develop something on that transfer site,” absolutely, and that is why we approved the Redevelopment Plan which creates a zoning for that site and it goes only from Berthoud to Madison. It does not create any precedent for other development around there. Any other development – I know there have been presentations on this – it is on the website if folks want to pull it up – that describe what would happen if the buildings around that were to be developed. They would fall under the normal zoning. So just to clarify, I hope that it gives some people some more information. So with that said, I’ll stop talking. If anyone else wants to comment from the Council, but if somebody wants to ask any other questions, I’ll take the next person.

Al Cunniffe – 42 South Maple Avenue – I understand everything that you said. I just want to reiterate just a little bit. I think a lot of you gentlemen know me. I have been a resident of Park Ridge for I think it is about 47 years, 1969. I have seen my kids grow up and go all through your school system, etc. so I’ve been a longtime resident. I am concerned that this does set a precedent and I just want to throw that to the Board so that you understand my concern as a longtime resident. I am concerned that if you pass this, and you said it is just for a small area – and that was my big concern because you have what was Sony – which is just a few months ago wanted to put 500 units up there - the five story buildings as I recall or apartment houses, and that I believe would overwhelm your school system. It would also put a strain on your water system, your Police Department, your Fire Department in Park Ridge, and then you would face what happened maybe about eight or ten years ago when they wanted to pass the \$65 billion school increase in Park Ridge. I was part of that group that came down here and said, “Wait a minute – what’s going on in this town.” If you hold it to the five, I would of liked it to say three stories, like all the other buildings that I’ve seen, and I hope that it does wind up that you find somebody that could put a nice developed site with three stories and keep the building down. I am concerned about an explosion in this town that really puts a strain on the resources. I thank you.

Mayor Maguire: Thank you, Mr. Cunniffe. As I said earlier, it is restricted to the redevelopment zone and that redevelopment zone is clearly and distinctly identified as that block that the waste transfer site is on between Berthoud and Madison. Any other development around there would require other zoning changes. It would have to go through a whole zoning process and there is no intent to do that. The definition of a redevelopment zone is for it to become a catalyst for the areas around it. By creating this one development, and we are already seeing it, it makes the properties around it more valuable and it makes the properties around it more attractive for businesses. Folks, many of you are not familiar with, but if you talk to the business owners in town a lot of the small business owners struggle. They struggle and you will see that some of the restaurants they change regularly and it is because they don’t have that focal point-

that redevelopment zone is going to create that for them and it is to be the catalyst for the areas around it and that is the whole goal of a redevelopment zone and if you look at the definition that is what is in there.

In terms of the impacts – what will happen now is we passed the zone – we created the zoning. A developer will come in and they will present something, and that something we have concepts on in terms of how many rental units or units will be in there which will then trigger how many students and based upon the analysis we've done, there will be at most twenty-six students attending the schools and that is the high end. The low end was fifteen and there are two different studies – there are methodologies that are used to determine that and it is between fifteen and twenty-six would come out of this development, conceptually, and that is when the development and the plan is presented that analysis would be done again and that impact analysis would be done again. Just some additional information.

Eleanor Fragiaco – **114 Berthoud Street** – and five stories – that is a very busy corner. You are going to have two drive thru restaurants – now five stories – and I guarantee you, that you will be a precedent set in this town and it is just unfair. That's it.

Mayor Maguire: Thank you.

Brenda Yanni – **38 Glendale Road** – I was here when you talked about the redevelopment zone originally and I heard that people came out on the day that you had this vote and were told that you weren't going to vote about it and left, and then suddenly this vote was held and you had this vote with none of the people who wanted to discuss it here, which I don't think was quite fair, but that is neither here nor there. You can't say that is not precedent setting. Once you allow something, then the next builder who comes in is going to say, "You did it for them, do it for me" and this happens all the time. It happens when you create these monster houses where there weren't monster houses before when they want to go in and do something and you are not going to fight all of those battles. Some of them you are going to say, "O.k., we give up" because you don't want to fight with the developer who has more money than you have. A precedent is a precedent – once you do it, it is done. You say that you don't have a builder so you didn't have to create a redevelopment zone that allows five stories. You could have left it at three stories, and if your builder came in with a plan that was five stories, because you say you don't have a builder yet, then you could have looked at it then – but you have already said it can be five stories which means whoever comes in is going to want five stories because they are no fools – they've already heard it. You can't say that it won't be. I have nothing against mixed use – I don't care about mixed use – I think it is a wonderful thing. You want to have a redevelopment zone, that is fine, but five stories in this town is wrong and it is precedent setting. I don't believe that you would only have fifteen students or twenty-six students or how many you have – either I don't think it is possible in the size that you are talking about. You may think so, I don't think so, and I don't think most of your audience thinks so –but I know for sure that once you have five stories, the next builder coming in is going to ask for the same thing and it is going to be very hard if not impossible for you to fight their lawyers when they want it.

Mayor Maguire: Thank you. I can certainly ask some of the experts to explain but I will try to. There is no precedent. It is something called "creating the zones." What we had to do here was declare the area an area in need of redevelopment and then create the Redevelopment Plan. This has been going on for well over two years. It is not an easy process. It is a many, many step process. A lot of public hearings were held on this and I don't know where the confusion was in terms of the meeting that you attended. There have been many, many meetings held on this to declare this area an area in need of redevelopment, create the Redevelopment Plan, and then create this redevelopment zone. To have someone outside of this redevelopment zone come in and say, "we want the same thing that is in the redevelopment zone" that will not and cannot happen. I'll just clarify that.

Pat Hunt – **154 Spring Valley Road** – Mr. Cunniffe, you have a couple of years on me – I am a forty-four year resident of Park Ridge. I grew up on 2 Mader Place and I can remember in the early 1980's as a young man, the consternation about the building of the Hertz Building – the Sony Building – the Marriott Hotel – the NUS Building. At that time, we had all of the same concerns regarding the three story limit and those developers wanted to build taller buildings,

and the town at that time, against, maybe in those days much stronger developers, limited the building to three stories. There was a lot of consternation about what we would have to do as a town with our Fire Department, and we wound up buying a larger fire truck to support that infrastructure, and the question would be what strain on our resources would we need for this larger building?

I am also the President of the Park Ridge Athletic Association and I can tell you that the children in this town grades Kindergarten through 8th Grade – the fields, the basketball courts, the facilities that we have are under a tremendous amount of strain. I can understand the statistics that you quote, but there is another statistic that says 68 ½ % of all statistics are made up. I would caution you, and again speaking on behalf of the Park Ridge Athletic Association, there is a tremendous amount of strain on our facilities. We spend about \$18,000 a year to fund our basketball program. You may or may not be aware, we have one full size indoor basketball court in town and that is not enough to support what the Athletic Association for our children want to do. The fields are strained. The PRAA paid for the rehabilitation of a couple of the baseball fields. I, myself, am out there working on a baseball field. The town does a very good job in supporting us so I appreciate that, however, I would ask the Council to consider some of these ancillary things for the children of Park Ridge.

Mayor Maguire: Thank you, Mr. Hunt. I will try to address your comments. In terms of the fire apparatus, there would be no additional fire apparatus required. This would be based upon our analysis of what a five story building would be, would be 58 ft. The Wells Fargo Building is 50 ft. to give you some idea. In terms of the height, just so folks know, I would love to keep it at three stories, but when we looked at this, and we said, “O.k. – and we created a zone that would allow a developer to come in, and if we did, if we limited it to three stories, it may not happen.” By putting it in as five stories, we allow a developer to come through and certainly we are going to do the economic analysis on it. We have retained economic financial advisors who would review a plan that is presented to the Borough. What has been discussed at this point with the majority of the building being four stories – and the fifth story being set back off of Kinderkamack – so certainly something that the Planning Board, the Planner, the Engineer, as well as this Council, have all thought about - looked about – looked at – because certainly there is a concern that the five stories is high. It is something that would be new to Park Ridge and something we thought long and hard about, but in terms of the general height and the fire apparatus, we are looking at about 58 ft. and the fire apparatus would be able to handle that.

David O’Sullivan – 252 Capri Terrace - I just wanted to do some follow ups real quick – I know that at the last two Mayor and Council Meetings I had brought up the issue of Park Ridge TV either streaming live or taping public meetings. I just wanted to know if there was any update or any progress on that endeavor.

Councilman Oppelt - Smile, you’re on candid camera.

Mr. O’Sullivan: I wasn’t sure exactly – I wasn’t sure if she was a private resident – that is great. What will happen – will that be posted on or website then for people?

Councilman Oppelt: No, it will be on PKRG – Channel 22 or 77.

Mr. O’Sullivan: Great – fantastic. Also, I just wanted to know has there been any communication with Hornrock Properties and if so what have those discussions been?

Mr. Ten Hoeve: There have been none yet.

Mr. O’Sullivan: Is there any indication that they may be on an agenda or work session soon? I know there was some communication where the said they may be coming in for a work session.

Mr. Ten Hoeve: There is nothing scheduled. They are not listed on any agenda and they are not coming before the Council at any time that we know of right now.

Mr. O'Sullivan: As far as notice, I know that you guys put an agenda out. When would the residents of Park Ridge see that agenda so that everybody that would want to attend could be here.

Ms. O'Donnell: It is on the website usually by 3:00 pm the Friday before the meeting.

Mr. O'Sullivan: So the Friday before the meeting – so four or five days before the meeting we would have that...o.k. Last two items – as far as the rezoning that was requested by Hornrock Properties – I know the Planner is working on the reports still – has that been completed at this point or no?

Mr. Ten Hoeve: Not to my knowledge.

Mr. O'Sullivan: As far as an update on affordable housing, I know that we are in front of the Court Master. I know that we submitted some sort of plan. I just want to know if there was any response from the Court Master concerning affordable housing obligations.

Mr. Ten Hoeve: That I would have to check on. I don't know for sure. We haven't had any court appearances recently and it is actually before a Superior Court Judge. A Special Master is someone who has also been appointed by that Judge in order to try and help facilitate some settlement.

Mr. O'Sullivan: So there has really been no communication back and forth from the courts on that?

Mr. Ten Hoeve: I don't think there are any documents at all. Understanding that I might if there were documents tell you that we are in litigation and I wasn't going to give you anything, but notwithstanding that, I don't think there has been any documents since everything that you've already been provided with.

Mr. O'Sullivan: Thank you.

Mayor Maguire: Thank you, Mr. O'Sullivan. And just another comment – a lot of this all came out of a visioning process that was conducted several years ago where residents were invited in and asked to look at what they would like to see in the downtown. The area in question here, this redevelopment zone, was something that consistently came up in the different groups. They had everybody go into groups and then each group went and formulated what they thought would be appropriate for downtown development and the waste transfer site was for obvious reasons something that kept coming up as something we didn't want. We didn't want the truck traffic – we didn't want a waste transfer site in the center of town – so that is where this idea of this development originated many years ago. It also then talked about what we could possibly do to improve parking. There was a consistent concern that there is a lack of parking in the downtown and what could we do to capitalize on the commuter lot. There was also a concern that we didn't have the recreation facilities so there was a need specifically identified for a basketball court. There were also needs identified for senior meeting places. All those things came out of the visioning process and were incorporated into goals and objectives that the Planning Board and the Mayor and Council have strived to include. As we go through this process, we have been trying to think about how do we include those goals and those things identified into this redevelopment zone. One of the things we've talked about is putting a parking deck on the commuter lot and as part of that it would include an additional community space which would also include a basketball court – was one of the ideas that was put forth along with a senior type of meeting room as well. This is all the concepts that are being put forth as being under the umbrella of a possible development within the redevelopment zone – so just to give you some additional background on what the Council is thinking and where this is all coming from. It is not something that we are all just trying to push through development for ratables sake – that is the last thing that we are doing here.

Section 5. To finance said purpose, bonds of said Borough of an aggregate principal amount not exceeding \$180,000 are hereby authorized to be issued pursuant to the Local Bond Law. Said bonds shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law. All matters with respect to said bonds not determined by this ordinance shall be determined by resolutions to be hereafter adopted.

Section 6. WHEREAS, the governing body of Borough of Park Ridge has determined that certain procedures need to be established to accomplish this policy.

NOW, THEREFORE BE IT ADOPTED by the governing body of the Borough of Park Ridge that:

Section 1: No official, employee, appointee or volunteer of the Borough of Park Ridge by whatever title known, or any entity that is in any way a part of the Borough of Park Ridge shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional

rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Borough of Park Ridge’s business or using the facilities or property of the Borough of Park Ridge.

Section 2: The prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the Borough of Park Ridge to provide services that otherwise could be performed by the Borough of Park Ridge.
