WHEREAS, the Bergen Volunteer Center was founded in 1966 to meet community needs through the power of volunteers. Its direct service programs organize volunteers to provide invaluable support to some of Bergen County's most vulnerable citizens. The Mentoring Youth program has recruited, trained and supervised volunteer mentors for children who have been abused or neglected; since 1978 Mentoring Youth has provided a trusted mentor to more than 3,700 children. The Mentoring Moms program recruits, trains and supervises mentors for mothers whose children are at-risk for abuse or neglect; since 1995 more than 500 mothers have been matched with a mentor. The Chore Service provides home safety repairs for senior citizens and the disabled free of charge through the volunteer efforts of senior citizens. The Business Volunteer Council organizes corporations to help eliminate hunger and illiteracy; and

Interpretive Statement

A “yes” vote will permit Park Ridge to establish an Open Space, Recreation and Historic Preservation Trust Fund with an annual levy of up to 0.007 cents per \$100 of assessed real property value. The average owner would pay \$33 per year, which is equal to \$2.75 per month, for a period of 5 years. Funds can be used only for the development, maintenance and acquisition of lands for recreation and land and water conservation purposes, and historic preservation. An oversight committee of local citizens would advise the Borough on how funds should be spent. Every year there would be a public audit of all expenditures. The funds would enable Park Ridge to leverage matching grants from the county and state.

REPORTS OF THE GOVERNING BODY

Councilmember Bertini: Thank you, Terry. Today the Golden Age Club had a fabulous beginning of summer celebration. It was a luncheon. There was lots of singing –lots of dancing and at the end members of the club hold hands in a circle and sing God Bless America. It was just wonderful, and as they like to say, “growing old is mandatory, growing up is optional” - that is their slogan. In addition, I hope you’ve all received the new Borough Newsletter. It should have arrived with the copy of Community Life but there are also copies available at Borough Hall, the Library, and on our website so hopefully you will get to see that and we welcome your feedback. I have to say that having worked on it some, I am in awe of the enthusiasm and the hard work by so many volunteer groups and employee groups in our town and their enthusiasm and pride in their contributions to Park Ridge is really a wonderful thing. That was my big take away from the Newsletter. I would love to hear from anyone who has read it about suggestions for the next one which will be out probably in the mid to late fall. That is all I have for tonight.

Mayor Maguire: Thank you, June, and I couldn’t agree more. I got a lot of compliments on the newsletter so it is something that we wanted to reinstitute and now that we’ve been able to find a way to do it that is financially prudent, I am glad that we did it, so thank you for all your efforts and everyone that contributed to it.

Councilmember Szot: The Chamber of Commerce is working on a comprehensive email list of all the businesses in town so that they can make the communications more consistent with everyone and as far as the Technology Committee – I am going to be going to be going to various departments to ask them how things are going with our website and their access to the website and hopefully we can find a reasonable mechanism to get feedback from the community about our website.

Mayor Maguire: Thank you, Donna, and we all excited to attend the Starbuck’s Grand Opening the other day. They taught the Mayor how to make a cappuccino so it is a very exciting time for Park Ridge and the Chamber of Commerce as well.

Councilmember Szot: Absolutely.

Mayor Maguire: Thank you.

Councilmember Oppelt: Yes, Mayor. Just one item – following up on the business owners in town. We would like to thank them and Gwen Pardi with the Garden Club for all the flowers this year. I don’t know if you realize it, but a lot of the business owners actually are planting the flowers, unlike other years where the town paid for all of them. We’ve got quite a few of them out there and the watering truck that volunteered go around watering – so they’ve done a watering rain dance – hopefully that we get some more rain and we don’t have to do it quite as often. Gwen does a great job and she should be complimented.

Mayor Maguire: Thank you, Bob. I do receive a lot of compliments about the flowers. It certainly makes the town look nice and I know a lot of time and effort goes into that. Thank you.

Councilmember Misciagna: No report this meeting, Mayor. The Chief of Police is away on vacation. I should have something to report next meeting.

Council President Bosi: Thank you, Mayor.

On the Finance side - I would like to take a moment to recognize our finance team. Joe K. has been with us now for a little over a year and has guided the transformation of our finance team. Joe and his team have worked on many initiatives over the last year and it is very evident to the

Mayor and Council and our residents of Joe and his teams' hard work throughout the year. Thank you.

Roads- Just a reminder – the Recycling Center is open 9am-2pm on Saturdays. It has been super busy there. Keep in mind, that anything that we do put at the Recycling Center does not end up in landfills so the more we can put down at the Recycling Center is greatly appreciated.

On the Electric front - Despite the hot weather that we have had over the past few weeks, there have been no issues. I would like to thank Paul Longo and his team for continually “keep the lights on.”

On the Water- Again, with the hot dry summer we have had and with increased water demands, we have been able to meet the demands of our residents and customers. The Consumer Confidence Report will be in the mail by the end of the week so that will be in everybody's mailbox probably by Friday or Saturday is the expectation.

I would like to read an email that we received about one of our water employees from the Chief of Police:

“I would like to take this opportunity to recognize a water employee. I wanted to commend one of your employees for his actions on the morning of June 11th, 2016.

Dan Boyle was on his way to work on Pascack Road when he discovered a female passed out on the sidewalk. He immediately contacted our department for help. When my officers arrived, they found that the girl was completely unresponsive and barely breathing. The officers provided medical attention until the arrival of the ambulance personnel and paramedics. The girl was eventually brought to the hospital and is doing well.

I strongly feel that if Dan Boyle did not contact us the ending to this incident may have been tragic. I want to thank him for taking the time to stop and help this poor women in her time of need.”

I know the Utility Board and many members of the Mayor and Council have personally commended Dan Boyle for his action.

On the Library front - I encourage our residents to check out our library. They have many resources and activities for our residents and many summer activities which are just about to start.

And lastly, I would like to thank the Green Team for their efforts around town, especially around Mill Pond. There are several dedicated volunteers that are there probably a good three or four nights a week maintaining the plantings that are there. That is it, Mayor.

Mayor Maguire: Thank you, Rich. On a tragic note, folks have probably read there was an accident with fatalities on Park Avenue and three Park Ridge residents were involved and our thoughts and prayers go out to them and their families.

On another note, we also were made aware that on July 11th Brian Cushing, who is a Park Ridge resident, who is now playing in the NFL for the Texans, will be attending the Park Ridge Football Camp for the Youth – the High School runs it – the High School football coach. It should be a good event and we thank Brian Cushing and his family for coming and participating.
