- Over the last 40 years, the Fire Prevention Bureau under John's direction has organized an annual babysitting class for Borough children. Additionally, during Fire Prevention week, John leads all the activities at the local schools.
- John serves as an Officer of the Park Ridge Fire Department Welfare Association since its inception over 40 years ago. In his continuing capacity as Treasurer, John has approved funds to assist department members in their time of critical financial need.
- Park Ridge is in good hands under John's leadership and attention to detail. Words cannot express John's accomplishments over his six decades of service.

#### **PUBLIC PRIVILEGE OF THE FLOOR:**

Council President Fenwick asks if anyone present wishes to be heard on any matter.

Upon recognition by the Mayor, the person shall proceed to the floor and give his/her name and address in an audible tone of voice for the records. Unless further time is granted by the Council, he/she shall limit his/her statement to five (5) minutes. Statements shall be addressed to the Council as a body and not to any member thereof. No person, other than the person having the floor, shall be permitted to enter into any discussion, without recognition by the Mayor.

- 1. James Tesone Washington Township Resident- Resident spoke about how he is as a member of the New Jersey libertarian party and our preemptive ordinance repeal project. While each New Jersey town has a set of ordinances tailored to its specific needs you may be aware that towns are prohibited or preempted by the state from passing certain types of ordinances, nonetheless many towns have on their book's. his concerns were with: e Borough's two loitering codes, § 78-11 (Loitering, obstructing passageways prohibited) and § 78-21 (Idling or loitering prohibited; duty of policemen). Both are clearly preempted by state law and ought to be repealed and several other provisions within Chapter 78 which prohibit various other types of "Disorderly Conduct." The resident stated he sent the governing body an email where all of this is stated.
- 2. Susan DeLorenzo 22 West Park The resident had questions about the referendum wonder if the Borough is absolutely going forward or is this just a study, and if it's we're voting yet yes what actually are we voting yes to and how much of the monies that have been discussed are actual real numbers versus not real numbers and one more the actual

plan of the pond is it going to not just dredge but kind of put it back to what originally it was which is had banks and all kinds of different things because it's been eroded.

- a. Mayor Misciagna: Let me let me start and let you know how I think this started. We've been talking about fixing the pond for decades now, it's been getting worse with years. The referendum the place that it came from was a reporter had gotten several letters, Mike Olahan, asking what the Borough was willing to do about dredging. I said I wish it was the way it was and through a course of our conversation, I made an off-handed comment and said I'd be okay if they put it up for referendum. We got stuck with this I mean they did this 44 years ago was the last time we probably could have done it we probably could have maintained it better, there's a whole bunch of things we probably could have done. I can promise you this if it does get done there's going to be a maintenance plan going forward. The clarification that I made is the referendum says there's a 5% increase, most of the people that I spoke to thought that their overall tax burden was going to go up 5%, and they all almost passed out. I said it's not as bad as that, it's still an increase, it's 5% of the municipal portion of your taxes which is 24%. About 66% of your taxes go to the school, around 10% go to the county 24% go to the municipal. We are gauging the public's interest, this is a nonbinding referendum, it doesn't require us to go and spend \$15milijon. We have been vetting grants and applying to the federal, state and county government for assistance.
- b. Council President Fenwick: I have in front of me the letter that our auditor prepared, the actual debt service cost which is the tax increase on the municipal property tax that's affected it changes slightly from year to year, but it's about 4.91% on average and that increase. I the Borough decides to go forward with the project, if the referendum passes, that will be locked in for 20 years now in theory could the Borough you know make massive cuts to pay for that yeah, but nobody up here is talking about making the drastic types of cuts that we would need to do in order to cover that cost. It is a substantial amount of money that we would have to repay. I know what the mayor's saying if you look at it on your total tax bill including the school taxes and the County taxes, you would come up with a different percentage. But it is per our auditor uh on average per year 4.91% tax increase on the Municipal Taxes. per our auditor, Jeff Bliss, this is based off of a bond interest rate of 4% that could change now as we all know interest rates are going up. This was drafted several months ago so the Debt Service cost is likely going to be higher.

A discussion went on regarding questions on the referendum.

3. Burton Hall - 98 North Fifth Street - First everybody's confused about this just might the way to think about it is you're looking to get a 20-year mortgage on the future of millpond? That is what we are saying, there are some people that think their taxes are going to go up \$234 every year, if you think of it as a 20-year mortgage on the future of Mill Pond you might not like it you might like it but at least you understand it. Because otherwise, people understand mortgages. It's project discipline now one thing and clarify

this for me this is a non-binding referendum non-binding is the operative phrase. Let's say it gets approved that and and tell me if I'm wrong, but if you go okay, we're going to we want a bond for whatever our number does that go before with the voter's again in a binding referendum? **Council President Fenwick**: No, it does not, you can't have a binding referendum in a Borough form of government.

**Mr. Hall:** Would the money be dedicated solely to the Mill Pond project? **Mr. Schettino:** It could be, it depends when you do a bond ordinance you have to state with the purpose is so if the governing body decides to make that purpose solely the pond, then that's what it would be limited too.

Council President Fenwick: I will say, and I know Connie can attest to it, because when I first came on the council, I made sure that every bond that came up could be paid back early I wanted them to be callable because of the exact issue.

Mr. Hall: If we bonded the money you know so we can do the dredging, would that preclude the state or federal government from granting us money to do that job, which would allow us to pay down that bond? Mr. Schettino: No it would not, you have a better chance when you are seeking the money then when you have it. Mayor Misciagna: We would go for matching grants something before we would commit bonding the money. Council President Fenwick: In the referendum question if you notice at the very end it says that if approved the project could be done in stages. One of the things that that brought this up was we got the \$1.5 million Grant and the question was brought up well you know why don't we get started on doing engineering work and getting started on doing the licensing applications and I won't speak for everybody else but I felt that if we didn't know that the town was behind the project that it wasn't right to spend the money on those things. We would never get it back if the town wasn't in favor of it so one thing that I think we could do is if the referendum passed, we could get those licenses we could do the engineering and then apply for the money like the mayor is saying because then we'll have a we will have a more plan to show people so that people know.

Mr. Hall: Would the contract include a no prepayment clause? Mr. Schettino: Yes, the ordinance is prepared by Bond counsel and they always recommend its recordables and even more so when the interest rate is high. When the interest rate was 2% and I saying even then they would recommend it not being recallable but there'd be more of an argument saying is it ever going to be lower than 2%, so they with the interest rates where they are they want it to be callable so the opportunity to refinance is there.

**Mr. Hall:** I think it is very important to have a sunset clause. I'll just say it anyway is too many tax increases are in perpetuity. This is a 20-year tax increase at the end of 20 years it's wiped, so that a sunset clause. **Mayor Misciagna:** I am in favor of this as is the whole Council I believe.

A discussion went on regarding The Mill Pond dredging referendum.

- 4. Heather Mannucci- 4 Quackenbush Lane We tried to brainstorm with parents how we can get this passed. I think people have no clue what the municipality you know percentage was and that it's only a little portion and that it's 20 years. I just I guess I wondered if you have any plans to sort of try to get more information out. I know you've sent a couple of emails in the past few weeks but I think people are really lacking the understanding they need to vote. I guess the only other question that I have, is I mean if the vote doesn't pass which is kind of my fear I feel like people aren't going to vote yes. because they just have not enough understanding around what they're voting yes for. what what's next? Mayor Misciagna: I've said before I'm committed to advocate for funds for this project regardless of where they come from. Right now we are at a point to see if residents want to help us get money, I think it would be easier for us to get grants if we had skin in on the game. We have talked to the federal government; we have been dealing with this well over a decade and tried to vet out everything and options. We have gone after every grant we could. Councilman Capilli: I don't think anybody doesn't want it to happen, but I can just say personally I just don't want it to be on the backs of our taxpayers. I just feel like we're taxed to the hills everywhere, so I'm not looking for it to be there, but like the mayor said if we can continue to look for sources of other revenue streams from federal or County or wherever source. There is a maintenance factor that goes into it too and I'm sure engineer could speak more to that, but there's some sort of I don't know what you want to call it underwater catch basin. If we put it in, that has the the silt has to come out of it it's not just as simple as even if it were 15 million we're going to fix it once and then we just wash our hands of it. It it's an ongoing cost that we're going to see yearly to maintain it and that I don't know it could be \$1,000 or 10,000. I have no idea what that costs, but there's a cost associated with it. Council President Fenwick: There has not been money set aside for maintenance of it, any way we can find a way to address the pond that is cost effective if it fails.
- 5. Liza Falato Lou- 5 Williams Crest One of the things I was wondering, and I know other people that I speak to other residents were you know asking about is, what is the status of the Community Center and what happened to the money that was promised us by the developer? Mayor Misciagna: The council decided not to build it they voted to not build it. We got \$750,000 from the Builder to build a rec center, at the time we thought it was 2.5 million and COVID hit, and prices quadrupled and this Council said we're not going to spend that much money because they don't want to they don't want to raise taxes or to bond. Council President Fenwick: Estimated we were getting were around \$8million. Councilman Ferguson: Yes at the time we voted it down because it was way too much money, but to me personally it is not dead in my head. I think it's something that we got to get through this dredging and then this was going to be like a project for me next year, the project is not dead. Liza Falato Lou: So then that money did not get used up? Councilman Ferguson: It's in a dedicated account.

#### REPORTS OF THE GOVERNING BODY

Councilmember Hoffman: I just like to say congratulations to everybody who won a community service board tonight, you guys really are the people who make Parkridge such a great town. I've lived here for 30 years and it really is a gem as the mayor likes to call it the gem of the Pascack Valley.
