Sony Property: As of today, we have not received an application or site plan. The only work taking place now is on the Montvale portion of the site.

Bears Nest: The DEP is currently conducting an environmental study in the wooded property next to the Bears Nest. No trees are being cut down or harmed in any way.

The James Building: The building is now 100% filled residentially with no increase of traffic or crime in our town. The retail is expected to be 100% filled by years end. A restaurant is close to signing a lease and a couple of the smaller stores have been rented.

Community Center: The application will only come back to this Board if there is a large change in the plans, which is not expected. The Borough is working on the funding for the project.
